It is a good idea to leave a key with

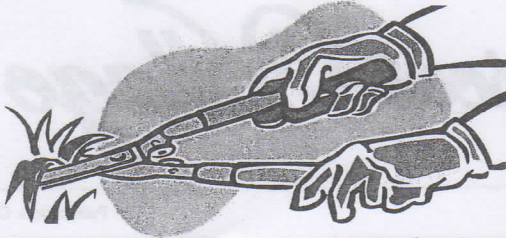

Treasurers' Report

Our finances through August, 2016 are as follows:

Income	\$ 843,093
Expenses	\$ 841,103
Deficit	\$ 1,900
Variance over Budget	\$24,029
Reserve Balance 08/31/16	\$ 541,196

August was basically a break - even month, with an excess of \$1,460. This is very good thing considering the high heat we endured during the month. We now have a significant overage compared to budget so, barring any unanticipated large expenses, I am confident we will be in good position through the end of the year.

The 2017 Budget has been approved by the Mutual 10 Board of Directors. I had a few calls with questions about specific e-rating adjustments. I do not yet know the exact condo fee by unit for 2017 but should have that information within the next couple weeks.

I am happy to say that delinquencies in Mutual 10 are minimal. Recently, a resident was late with her payment because she went out of town and forgot to make the payment before she left. Forgetting can be costly, since out late fee is \$50.00. If you are not currently signed up for automatic payment of your fees, I strongly urge you to do so. Simply take your checkbook to Accounting in the Administration building. They can get all the information needed from a blank check and it only takes a few minutes to sign up.

LWCC BOD Summary

9/27/16 Meeting:

The LWCC BOD summary is:

1. A resolution was passed to engage with Environmental Quality Resources for the Golf Course Rehabilitation project— with funding to come from the Facilities Enhancement Fund (resales).
2. A resolution was passed to proceed with various IT projects: website development; payroll and human resources software; Telephony System funded by the Telecommunications fund and Clubhouse Event Management software.
3. A resolution was passed to submit the final site plan for the clubhouse north wing, administration building, the Clubhouse Grille, and all associated parking for the state and county regulatory process. The time estimate for completion of the process is 18 months.
4. The LW 50th Anniversary committee was recognized for its tremendous efforts in planning an extremely successful week of community activities .
5. Medstar sent a letter of intent to LW informing them of their decision to extend their community services contract. They have requested some contract modifications, which will be addressed.
6. The newly hosted organizational-wide telephone system is being installed and should be operational by October. The current Verizon telephone system is costing \$5k-\$6k per month and will be avoided with the new host system.

Summary of Mutual 10 BOD Meeting



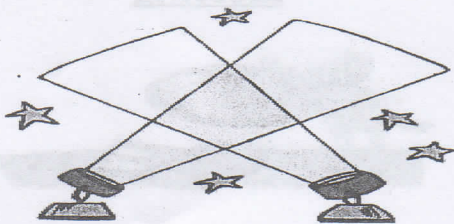

10/27/16 Meeting:

The LWCC BOD summary is:

1. A budget surplus through the end of August was realized, which bodes well for a year-end surplus.
2. The LW budget was approved by the Board of Directors - increasing facility fees by 3% (\$166.50).
3. Bank of America will be vacating from the LW Administration Building in mid- November. Presently, negotiations are under way with Sandy Spring Bank to replace them at the same location.
4. Comcast will have an open house in the Crystal Ballroom on October 25. Representatives will be there to assist residents with billing questions and package possibilities.
5. Vice President LeRoy Salazar noted that all original sliding doors in 28 units have been replaced.
6. A discussion about dryer duct cleaning was to determine if it should be an owner or mutual responsibility. Chairwoman Pugliese suggested an outreach to residents who would like a cleaning, and the mutual would try to get a bulk rate price depending on the interest. This will be pursued.
7. All ABM's were approved pending the acquisition of all required permits. The one exception was a denial to replace a sliding glass door with a picture window.
8. It was noted that our Mutual now has 10% of homes as rentals. (We have 158 units in all) A possible by-law/rule change may be needed to cap the amount at this percentage. An excess of 10% is considered by many banks to be more risky for bank loans and they might tighten owner qualifications. Also, the chance for mutual quorums decrease as the number of off-site owners increase.
9. Dottie VanScoyoc reported that the Mutual 10 Fall Coffee will be on October 22 in the newly renovated Maryland Room of Clubhouse 1. See flyer

Mutual 10 Neighbor Spotlight

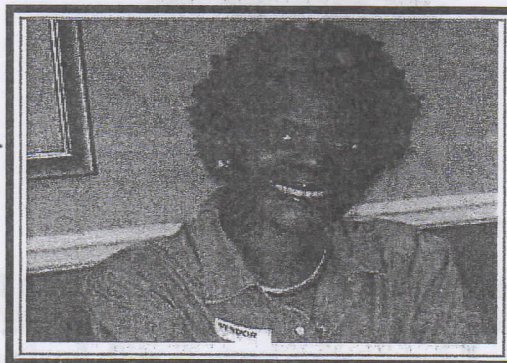


Meet: Angel Griffith, 10/4/2016

Angel came to live in Leisure World's Mutual 10 over 2 years and 8 months ago. She very much enjoys her time here. Coming from Brooklyn, NY, the adjustment from an urban environment was not too hard as she had visited Maryland before. A big reason for coming here was the leisurely atmosphere that was more accommodating and accessible for recovery from significant medical issues - thus improving her quality of life.

Having been born in Panama with close relatives from Jamaica and Barbados, Angel was exposed to many cultures and speaks Spanish fluently. At age 12, with her mother having done seasonal work in NYC for many years, the family immigrated to Brooklyn. While in NY Angel obtained her Master's Degree at New York University as well as her license in Mental Health - specializing in geriatrics and mental health services for dementia/Alzheimer's patients. Angel is a proud member of the Alzheimer's Association NY Chapter as well as a certified trainee. In NYC she was the Program Coordinator to a day treatment program for older adults and seniors. The program is in the hospital behavioral health department and funded by the city so she was actually a city employee. Non-medical day treatment programs were developed for seniors with beginning Alzheimer's/dementia. Daily programs included artistic expression, exercise, health education, talk groups, social interaction and field trips. Within the hospital there was much outreach to the community to bring awareness to families in need of supportive services. Angel's fluency in Spanish (her primary language) greatly helped with communication.

Now enjoying her time in Mutual 10, she serves on our Hospitality Committee and is quite willing to offer any of her senior care services expertise. She can also be seen walking her small dogs around the neighborhood.

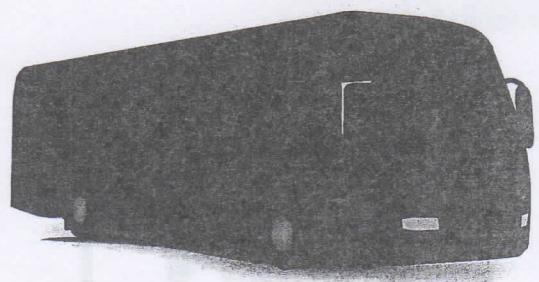
